SUBJECT: NW 70th AVENUE RECONSTRUCTION PROJECT UPDATE

It is with great excitement that the City of Johnston delegation returns to Washington, D.C. as part of the Greater Des Moines Partnership's 2005 26th Annual Washington, D.C. Trip. Since our last visit in June 2004, a great deal of progress has been made on the City's NW 70th Avenue reconstruction project, the following is a brief synopsis of those changes:

- The City of Johnston has completed design of Phase 1 of the project, with construction to begin in July 2005 with completion in the fall of 2006.
- The City of Johnston anticipates commencing design of Phases 2 and 3 of the project by January 2006 to allow construction to commence by the spring of 2007.
- The Des Moines Area Metropolitan Planning Organization (MPO) has increased its funding participation by funding an additional \$1,250,000 in 2007 and \$875,000 in 2008 for various phases of the project.
- The City of Johnston requests \$7 million in federal funding (\$5.0 million in 2006, \$1 million in 2007 and \$1 million in 2008).

I encourage you to review the enclosed Executive Summary, Letters of Support, Project Maps and Cost Estimates for additional information on the NW 70th Avenue reconstruction project. The City is hopeful federal funding assistance can be made available so that we can proceed with reconstruction of this roadway, in a timely fashion.

Thank you for your continued support and consideration of this project. If you have any questions, please visit with any member of the City of Johnston delegation during our visit to Washington, D.C.

Executive Summary NW 70th Avenue *City of Johnston, Iowa*

NW 70th Avenue has taken on a significant role in Homeland Security for the United States of America and the State of Iowa. Since the events of September 11, 2001, all traffic entering or exiting Camp Dodge has been diverted to a secured entrance on NW 70th Avenue. The road not only serves as the **only** access to Camp Dodge, but also, plays a significant role in the transportation system of Northwest Polk County:

- NW 70th Avenue was once part of the State of Iowa highway system (US Highway 44);
- NW 70th Avenue serves as a primary access to the Saylorville Lake Recreation Area, a U.S. Army Corp of Engineers project;
- NW 70th Avenue serves as a major commuter route for Northwest Polk County providing access to and from the Des Moines metropolitan area; and,
- NW 70th Avenue is one of only two east/west connectors in the City of Johnston (the other is NW 62nd Avenue).

Homeland Security and Camp Dodge

Due to the increase in traffic, the age and condition of the road, NW 70th Avenue is in need of reconstruction to meet the current and future needs of our country's Homeland Security and the regional and local traffic demands. Factors that support the immediate need for road improvements include:

- In August 2004, two soldiers being deployed to Iraq were killed in a truck rollover accident on NW 70th Avenue just west of the Camp Dodge entrance. What caused the truck to leave the roadway is unknown; however, the fatalities could have been prevented had the roadway not had such steep rural ditches.
- Camp Dodge has been heavily tasked to fight the war on terror by mobilizing forces for Operation Noble Eagle for homeland defense, Operation Enduring Freedom in Afghanistan, Iraqi Freedom and KFOR in Kosovo.
- Due to the Department of Defense Base Realignment and Closure Plan, a new Armed Forces Readiness Center, a U.S. Army Recruiting Battalion, and United States Marine Corp and Navy Reserve Units are planned for the Camp that would house up to 250 full time personnel and support 1,000 troops.

- Camp Dodge has been approved as an equipment rebuild site to repair battle damaged vehicles and weapons systems. This unit will consist of 200 full time soldiers and be operational in June 2005. This unit has the potential to double the amount of truck traffic into the Camp.
- Since September 11, 2001, Camp Dodge has processed over 6,500 Guard men and women for active duty.
- Camp Dodge was recently designated as the Regional Training Center for Counter-drug activities. It will serve more than 2,500 trainees per year.
- Camp Dodge serves an important role for Iowa communities as it is home to the Iowa Law Enforcement Academy.
- Camp Dodge is a growing regional training center, which currently provides training to approximately 400,000 soldiers, sailors, airmen and Marines from Iowa and surrounding states on an annual basis.
- Camp Dodge hosts 140,000 civilian personnel each year for training, meetings, conferences and youth activities.
- Camp Dodge estimates that annually approximately 50,000 service, contractor and maintenance vehicles enter and exit the facilities in addition the other traffic previously discussed.
- Camp Dodge hosts a number of tenant agencies including:

Traffic Counts and Movement

Traffic counts taken in 1996 indicate NW 70th Avenue carried 3,700 to 5,700 vehicles per day. Traffic counts taken in 2000 indicate an increase to 8,400 to 8,600 vehicles per day. Based on the City's comprehensive planning process, traffic counts on NW 70th Avenue are estimated to increase to 11,350 by 2007, and more than double the current traffic to 19,500 by 2012.

During the floods of 1993, access to Camp Dodge from the west was cut off due to the flooding of Beaver Creek over the roadway. Personnel trying to access the Camp from the west had to travel through Granger, Iowa. The current condition of NW 70th Avenue is inadequate for military convoy usage. The road is heavily traveled, it has inadequate shoulders and there is a high risk for accidents. The efficiency of the road is limited due to the lack of turn lanes and other improvements. Traffic flow is often interrupted as the city repairs the deteriorating road surface. The city has completed as many as 70 concrete patches in any given year.

Project Description:

The project consists of reconstructing NW 70th Avenue from NW Beaver Drive to NW 86th Street, the NW 70th Avenue interchange with Merle Hay Road and a segment of Merle Hay Road. The following is a brief description of each of the project phases:

- Phase 1: Includes the removal of the NW 70th Avenue/Merle Hay Road interchange and reconstruction of the interchange to an at grade signalized intersection, reconstruction of Merle Hay Road from Northglenn Drive to NW Beaver Drive to a four-lane roadway with turn lanes, and reconstruction of NW 70th Avenue from NW Beaver Drive to just east of Northglenn Drive.
- Phase 2: Includes the reconstruction of NW 70th Avenue from the Phase 1 terminus to near the Camp Dodge/Pioneer Hi-bred International, Inc. entrances to a four-lane roadway with turn lanes at Northglenn Drive.
- Phase 3: Includes the reconstruction of NW 70th Avenue from the Phase 2 terminus to NW 86th Street to a four-lane roadway with turn lanes and traffic signals at the Camp Dodge/Pioneer Hi-bred International, Inc. entrance.

In June 2003, the City completed a traffic analysis study, which indicated that the traffic on NW 70th Avenue will more than double in the next ten years to more than 19,000 vehicles per day. Based on this information, it is the City's belief that a four-lane roadway from Merle Hay Road to NW 86th Street is necessary.

Project Funding and Scheduling:

The total cost of the project is approximately \$17.98 million, in order to maintain access to all properties during construction and to maintain a realistic construction schedule the project has been phased over a three-year period. The City has to date secured \$3,449,087 in Surface Transportation Program funds in Federal Fiscal Years 2005-2008, allocated by the Des Moines Area Metropolitan Planning Organization (MPO) for the NW 70th Avenue/Merle Hay Road Intersection segment of the project. The table below provides a breakdown of costs by year reflecting the revised project costs:

The NW 70th Avenue project began in Fiscal Year 2004 with design Phase 1 of the project. Phase 1 of the project will be constructed over a two-year period beginning in July 2005 with completion in the fall of 2006. Phase 1 of the project includes reconstruction of the NW 70th Avenue/Merle Hay Road intersection and reconstruction of Merle Hay Road from Northglenn Drive to NW Beaver Drive. It is anticipated design of Phases 2 and 3 of the project will begin by January 2006, with construction beginning by the spring of 2007 (see attached map depicting year of construction for each segment). It is anticipated construction will take two construction seasons, to ensure uninterrupted access to Camp Dodge and Pioneer during the entire reconstruction process.

The City of Johnston has made a tremendous investment in Phase 1 of the project, relying on only local funding for the remaining phases of the project will significantly delay the completion of the total project, most likely extending the project from four years to six or more years. Typically, the City uses special assessments, to benefited property owners, as well as proceeds from General Obligation Bonds as methods of financing road improvements. A majority of NW 70th Avenue from NW 86th Street to Merle Hay Road is bordered by Camp Dodge on the north and the Pioneer Hi-Bred International Research Fields on the south. With Camp Dodge being a non-tax producing government property and the Pioneer Hi-Bred property having the ability to agriculturally defer the assessment, a significant financial burden is placed on the residents and businesses. Therefore, due to the increased importance NW 70th Avenue now has to Homeland Security, the City of Johnston is seeking financial assistance, as identified above, from the federal government to fund the improvements to NW 70th Avenue.

Metropolitan Support

This past year, the Des Moines Area Metropolitan Planning Organization again verified its support of the NW 70th Avenue reconstruction project by providing an additional \$1,250,000 to Phase 1 of the project and \$875,000 to Phase 3 of the project, bringing their total contribution of Surface Transportation Program funds for the entire project to \$3,449,087.

In addition to providing funding, the Des Moines Area Metropolitan Planning Organization has been instrumental in supporting the project the past couple of years in many other ways. Realizing the importance of the NW 70th Avenue project the Des Moines Area Metropolitan Planning Organization upgraded the Federal Functional Classification on the roadway from Collector to Minor Arterial in November of 2002. In January of 2003, the Des Moines Area Metropolitan Planning Organization further supported the project, by amending the Horizon Year 2025 Long-Range Transportation Plan to include the NW 70th Avenue project. In addition, many other state agencies and local governments have supported the project including, Polk County, the City of Grimes, the lowa Department of Transportation, and the lowa National Guard (Camp Dodge).

Environmental Impacts

McClure Engineering Company, on behalf of the City, has contacted various agencies concerning the environmental impacts of the project; the following two pages discuss their findings.

On behalf of the Adjutant General of Iowa, I am writing to express our full support for the Northwest 70th Street improvement project.

As you are well aware, the Iowa National Guard has been heavily tasked to fight the war on terror by mobilizing forces for Operation Noble Eagle for homeland defense, Operation Enduring Freedom in Afghanistan, Iraqi Freedom and KFOR in Kosovo. In fact, since 11 September 2001, we have mobilized over 6,500 Guard men and women, all of which were processed at Camp Dodge for active duty. By closing the two gates on NW Beaver Drive for security purposes, all traffic into Camp Dodge must utilize NW 70th thus creating a significant increase in traffic volume.

In addition to mobilization operations, last year Camp Dodge provided training to approximately 400,000 soldiers, sailors, airmen and marines. During this same year an additional 140,000 civilian personnel used Camp Dodge for a variety of activities including training, meetings, conferences, and youth activities.

There are a number of tenant agencies permanently located on Camp Dodge. These include the Counter Drug Task force, Iowa Law Enforcement Academy, Veterans Affairs Records Center, Regional Training Institute, Iowa Communications Network, Department of Public Safety Communications Center, Gold Star Museum, Post Exchange, National Maintenance Training Center, Military Interactive Multimedia Center, and Ordinance Training Battalion.

In May of this year, the DOD Base Realignment and Closure plan (BRAC) for 2005 has proposed a new Armed Forces Readiness Center for Camp Dodge which will house the DOD Military Entrance Processing Station, the U.S. Army Recruiting Battalion, a USMC Reserve unit, USN reserve unit, the Troop Medical Clinic and additional Iowa Guard units. If approved, this \$20 million project will support an additional 1,000 troops and as many as 250 full time employees.

The U.S. Army Forces Command has also approved Camp Dodge as an equipment rebuild site to repair battle damaged vehicles and weapons systems. This program will be operational in June 2005 and will station an equipment maintenance company on Camp Dodge consisting of 200 full time soldiers. Damaged equipment from throughout the Army

will be shipped into Camp Dodge for rebuild and repair which will probably double the volume of truck traffic on NW $70^{\rm th}$ Street.

As you can see, Camp Dodge is a busy place. With the increased volume of military and civilian traffic being routed onto NW $70^{\rm th}$, our main concern is traffic safety. While we are not budgeted to assist with improvements to NW $70^{\rm th}$, we would do anything we can to support the project.

The City of Grimes is an active supporter of the efforts of both the City of Johnston and Polk County for the planned improvements of the NW 70th Avenue Project. Mayor Tom Armstrong, Council Member Mike Martin, Grimes Chamber and Economic Development Executive Director Aaron Chittenden and I will also be attending the Greater Des Moines Partnership's Washington D.C. trip in support of this project, as well as a potential extension of this project to include NW 70th Avenue west of Highway 141 as it then becomes IA Highway 44.

I am writing in support of the City of Johnston's request for federal assistance for the NW 70th Avenue Improvement Project.

As you know, the cities of Grimes, Johnston and Urbandale have been working with Polk County and the MPO to study the transportation system in the northwest portion of the metropolitan area. This study has primarily focused on the Highway 141, Highway 44 and I35/80 corridors adjacent to our communities. Based on this analysis, a number of improvement projects have been recommended to address traffic concerns and to encourage development. One of these projects involves the intersection of NW 70th Avenue and Highway 141.

The NW 70th Avenue corridor plays an important role in the development of our region. Since this roadway serves as the entrance to Camp Dodge, it carries a significant amount of military traffic.
